Treasurer's Report:

Robin Doody, could not attend today's meeting but sent the following message to Kristy Gould. Robin's message as follows: Currently our Bank checking account balance is \$20,593.67. I recently transferred the remaining Jan/February PayPal amount of \$712.51 bringing the checking account to \$21,306.18. Currently in PayPal for the March meeting we have \$3914.03 pending transfer to the checking account. I have a few more checks to deposit for the March event as well.
